Please note:

- Administration and support fees are non-refundable and are charged once per year.
- All students must live with a Glenfield College approved caregiver (either police-vetted homestay, designated caregiver (DGC) or a legal guardian/parent). All homestays and DGC are inspected and monitored according to the Code of Practice. This is included in the homestay administration support fee.
- For moves between homestays, this may incur additional charges if a student moves homes through their own volition or without cause. ( The school reserves the right to use its discretion on a case-by-case basis).
- Homestay fees: lump sum to be paid in advance. Special food requirements will incur an additional charge up to \$50 per week.
  - Funds are held in Trust and paid to the homestay parent every two weeks (in advance) and accounts for all funds held in trust.
  - Two week's notice must be given if a student wishes to change their homestay on their own accord.
  - Any funds remaining at the end of the student's stay will be refunded into the payee's bank account in their home country.
- The contingency fee or unused portion of homestay funds may be used to cover any fees outstanding that have not been paid.
- All students must have travel insurance which can be arranged prior to travel in their home country.
